Complimentary Registrations

Cancellation Policy

A refund of fifty percent (50%) of the registration fee will be granted where written notice of cancellation is received at least twenty-one (21) days prior to the commencement of the event.

A refund of twenty-five percent (25%) of the registration fee will be granted where written notice of cancellation is received at least fourteen (14) days prior to the commencement of the event.

Non-Attendance

Delegates who fail to attend the conference after the applicable cancellation deadline shall remain liable for one hundred percent (100%) of the invoiced registration fee.

Force Majeure
